





IV EDITION PHOTO CONTEST "TRANSFORMING SOCIAL REALITIES" YOUNG PEOPLE: LEADING THE WAY FOR CHANGE

Movement for Peace -MPDL- launches the IV Edition of the Photo Contest "Transforming Social Realities". Since its first edition in 2019, this contest has contributed to making visible the importance of citizen participation, social mobilization and the protagonism of collectives and individuals who, through their principles and actions, transform realities of injustice and inequality in our societies.

This fourth edition, under the subtitle "Young people: leading the way for change", hopes to reflect, through images and stories, the role of young people involved in the collective defence of social rights and the sustainability of life.

Traditionally, children and young people have been denied the possibility of generating proposals in social and political issues. Their critical views of reality and their participation in decision-making processes related to our common future preservation have been ignored. However, with their own momentum, they have shown they want to participate in these debates all over the world, through their own strategies and highlighting different social issues of their interest: feminism, anti-racism, environmental care, LGTBIQ+ rights... Their opinions and actions are present in our daily lives, in schools, squares, neighbourhoods, towns and cities... This way, they demand an immediate shaping of tomorrow's world that counts on their voices and their agency.

In the European Year of Youth to be celebrated during 2022, it is more than relevant to recognise these actions carried out by young people in the construction of fairer and more diverse societies. This is why, in this edition, the "Transforming Social Realities" Photo Contest puts the accent on THEM.

PARTICIPANTS

Any person from anywhere, without age limit can participate. Children and young people under the age of 18 should also provide the consent of parents or legal guardians (see section 2.4).







THEME

The IV Edition of "Transforming Social Realities" aims to collect **photographs that represent** the actions of young people, individually or collectively, that contribute to social change and the defence of social rights.

- The photographs can reflect anything that the author believes contributes to the
 empowerment of women in society. The image should be accompanied by a short
 description of why she/he has chosen the photograph and what it represents.
- To guide your participation in the contest you can follow these questions:
- Which young people around you do you think have contributed to change in your neighbourhood, town or city? In what ways do they contribute to the defence of youth rights or, in a broader sense, of social rights that affect society as a whole?
- What forms of citizen participation within the youth movement (demonstrations, assemblies, meetings...) inspire you and do you think they contribute to the promotion of changes in society?
- What kind of acts of collective organisation or mutual support in the defence of social justice led by young people would you like to show?
- What kind of actions (small or large scale) do you think contribute to take more account of the youth voice in political decision-making?
- As a young person (if you are), what would you like to share in relation to your contribution to the construction of a better world?

CONTEST TERMS AND CONDITIONS

SECTION 1: PHOTOGRAPHS

- 1.1 FORMAT OF PHOTOGRAPHS: the pictures may be taken with any type of camera device (analogical or digital camera, mobile phone...) according to the following characteristics:
- Both Color or white and black photographs are accepted
- All photographs must be submitted in JPG or PNG format with a minimum resolution of 2160 x 1836 Mpx.
- In order to upload images in the web form, they must have a maximum size of 10 MB.

SECTION 2: HOW TO PARTICIPATE

- 2.1 DEADLINE: Photographs must be submitted between May 17th and June 17th 2022.
- 2.2 NUMBER OF PHOTOGRAPHS: Each participant may submit a maximum of 2 photographs.
- 2.3 HOW TO SUBMIT YOUR PICTURES: Photographs should be submitted through the web form that can be found on the website http://www.realidadesentransformacion.org/ . They must include a brief explanatory text and the following information:
 - a) Title of the work
 - b) Brief description of the work (maximum 2000 characters)
 - c) Country Location (where the photograph was taken)
 - d) Author: name and surname, address-place of residence, telephone and e-mail.

If a participant submits 2 photographs, he/she must complete the form for each of them

- 2.4 TRANSFER OF RIGHTS: to participate in the contest it will be mandatory to check the boxes on the form relating to the transfer of rights and referring to the following concepts:
 - a) <u>Transfer of rights by the participant</u>, or legal representative, for the use of their personal data and the photographs received in the framework of this IV Edition of the Photography Contest "Realities in Transformation". This transfer of rights implies that the organization MOVIMIENTO POR LA PAZ -MPDL- will have the right to reproduce, edit and exhibit the photographs, without limit of time or place, in any media or publication, always mentioning the author.







b) Transfer of rights by the person/s in the photographs by means of a Responsible Declaration of the author of the work on the permissions and consent obtained to use the image of the person/s appearing in the photographs. The author/author is responsible for any legal and juridical incidence on its use in the IV Edition of the Photography Contest "Realities in Transformation", exempting Movimiento por la Paz-MPDL from any responsibility.

If the photographs show **children and young people under 18 years of age**, they may appear with their backs turned or from a perspective that prevents them from being recognized. If they are recognizable, the author of the photograph must indicate on the form that he/she has the consent of the mother/father or legal guardian by checking the corresponding box.

2.5 UNDER 18 PARTICIPANTS: In the event that the participants are under 18 years of age or are under the guardianship of a person or entity, they must indicate this on the entry form and include the details of the person or entity.

It will be an indispensable requirement to be under the supervision of a parent or guardian throughout the participation process for those under 18 years of age.

- 22.6 RESPONSIBLE DECLARATION ON THE UNEDITED AND ORIGINAL NATURE OF THE PHOTOGRAPHS: No photograph whose intellectual property rights do not belong entirely and without exception to the person participating in the competition will be admitted.
- 2.7 ACCEPTANCE OF THE PRIVACY POLICY ON PERSONAL DATA: All participants must check the box related to the Privacy Policy on Personal Data agreeing with the following information:

"MOVIMIENTO POR LA PAZ, EL DESARME Y LA LIBERTAD (MPDL), informs you that your personal data will be processed for your participation in the III Photography Contest "Transforming Social Realities" including its public dissemination by the organization in public exhibitions, as well as any format and space they may consider appropriate for the promotion and visibility of examples of gender equality, solidarity and human rights anywhere in the world. The data will be transferred to third parties with your consent and to the extent necessary to suppliers or by legal obligation. You have the right to withdraw your consent, access, rectify and delete the data, as well as other rights, as explained in the additional information (click: protección de datos en nuestra web). SECTION 3: SELECTION OF PHOTOGRAPHS AND JURY

3.1 SELECTION OF PHOTOGRAPHS

The photographs received will be evaluated by the Department of Social Mobilization and Communication of the Movement for Peace -MPDL-, which will determine whether they meet the criteria and rules of the contest. Subsequently, the pictures will be evaluated by a jury composed of staff of the Movement for Peace -MPDL-, representatives of organizations and companies collaborating in the contest, and professionals with extensive experience in the field of photography. This jury will select the 12 finalists.

The 12 finalist photographs will be published on one of our social networks and/or digital platforms of the Movement for Peace -MPDL-, opening a period of public voting for the selection of the winning photograph of the contest. The photograph with the highest number of "likes" or "I love it" at the time of the voting closing will be the winner of the IV Edition of 'Transforming Social Realities' photo contest.

The 11 finalist photographs and the winning photograph will be made public as follows:

- During **the second half of July 2022**, the 12 finalist works of the contest will be announced, according to the jury's decision, and the period of popular voting will be opened on one of our social networks and/or digital platforms.
- On **1st August**, the winning photograph will be published according to the popular vote on our social networks. Participants whose works have been chosen as finalists and/or winners will be notified by email or phone call, as well as through our institutional communication channels.

The finalist photographs and the winner will be used for exhibitions, events or in those materials and spaces that the MOVIMIENTO POR LA PAZ -MPDL- considers appropriate for the promotion and visibility of the examples of social participation, solidarity and Human Rights in any part of the world, in line with the social causes promoted by the NGO.







SECTION 4: PRIZE

The author of the winning photograph will be invited to the closing event of the 14th edition of our Film Series for Peace, to be held at the Círculo de Bellas Artes in Madrid in October 2022. If the author of the winning photograph doesn't reside in the Community of Madrid, the invitation to the event will be made virtually. In any case, at this event, a recognition award will be presented to this person, after the screening of the documentary film which will close the Film Cycle. As far as possible, the meeting will give way aswell to the inauguration of the photography exhibition of the 4th edition of 'Realities in transformation', where the public will be able to see the 12 finalist photographs.

On the other hand, Movement for Peace - MPDL will support the publication of the winning photograph on Social Networks and will receive an online subscription to the Tiempo de Paz magazine for one year (https://revistatiempodepaz.org/)

Likewise, all finalists receive an individualized certificate as a finalist of the IV Edition of the Photography Contest "Realities in Transformation" of the Movement for Peace -MPDL-.

SECTION 5: EXHIBITION

The 12 finalist photographs will be published in the virtual exhibition on the website http://www.realidadesentransformacion.org/

During the fourth quarter of 2022, the photographs will be physically exhibited in ADIF's transit stations located in different Spanish cities to be determined.

SECTION 6: ACCEPTANCE OF THE TERMS AND CONDITIONS AND RESERVATION OF RIGHTS

MOVIMIENTO POR LA PAZ, EL DESARME Y LA LIBERTAD -MPDL- reserves the right to use, reproduce, edit and exhibit the photographs received in the framework of this IV Edition of the Photography Contest "Transforming Social Realities", without limit of time or place, in any media or publication, always mentioning the name of the author.

Movimiento por la Paz -MPDL- reserves the right not to admit photographs that, according to the criteria of the jury, do not comply with the technical, artistic and/or legal conditions required by the contest, or that hurt people's sensibility, incite violent or discriminatory behavior, or are contrary to the principles of the organization.

Any unforeseen event not contemplated in these rules will be resolved by the jury and the Department of Social Mobilization and Communication of the Movement for Peace -MPDL-.







SECTION 7: APPLICABLE LEGISLATION

Participation in the Contest shall be governed by the clauses contained in this document and, for matters not foreseen, by the Spanish regulations in force at the date of formalization of these terms and conditions.
